# **GrowFL 2013/2014 Statewide Initiative**

## **Participant information sheet**

## **Program Outline**

- 1. One year training and leadership development program for a minimum of 6 people, including CEO (required) and 5 employees 2 existing and a minimum of 3 new hires.
  - In-depth research access, working with a team of specialists in Marketing Strategy, Internet Marketing Strategy and Business Development.
  - Assistance for development and implementation of strategies.
  - Virtual collaboration center for shared interaction with the GrowFL specialists.
- 2. Once a month CEO Roundtables with peers to discuss strategies around solving specific business issues and further develop strategies for growth, if available in your community. (Additional charges apply and are not covered under the grant.)
- 3. Invitation to attend other networking and learning events throughout your engagement.
- 4. CEO enters into an agreement with the Florida Economic Gardening Institute at the University of Central Florida to establish the business's commitment to participate in the GrowFL program.

## **Eligibility Criteria**

- Be a second-stage company, headquartered in Florida and with intent and desire to grow.
- Fit general definition of second-stage growth company 10-99 employees and \$1 million to \$50 million in revenue.
- Be in a qualifying target industry.
  - o NAICS 31-33—Manufacturing
  - o NAICS 52 Finance and Insurance Services
  - NAICS 42 Wholesale Trade
  - NAICS 51 Information Industries
  - o NAICS 54 Professional, Scientific and Technical Services
  - NAICS 55 Management Services
  - NAICS 56 Administrative and Support Services
- Intellectual Property and/or strategy to sell outside the State of Florida
- Ability for CEO and 2 current employees to participate. Ideally sales and/or marketing staff.
- Ability to hire 3 new people within 12 months of approval into the program.



# **Description of Program Services**

## Individualized training services on business core strategy and sales development

GrowFL training services are provided by a team of specialists who will help you on a variety of business growth challenges you may be facing. You can obtain valuable information regarding vertical markets, industry trends, competitive intelligence and customer concentration maps all tailored to your business. Each company will be assigned a Lead Consultant who is certified in the Economic Gardening frameworks for growth. They will work to determine the scope of the training services, facilitate the involvement of the specialists, and be in frequent communication with the company throughout the program.

#### Access to the GrowFL Referral Network

GrowFL has established a sizable statewide network of referral partners, professionals that will work with our clients to provide operational and implementation services that fall outside the scope of our strategic focus. These include areas such as website and internet marketing, debt and equity capital, human resources and staffing, business risk and employee insurance, leadership and organizational development, and business process optimization and information technology services. Based on your request, our Lead Consultant will identify and facilitate an introduction to selected Referral Partners who will work directly with you.

# • Access to the University of Central Florida (UCF) Mentor Network for Entrepreneurs

UCF has a widespread network of experts ranging in experience from business and product management professionals to top industry executives and veteran entrepreneurs. All of these individuals volunteer their time to provide their advice and insights to you. Your Lead Consultant will work with each of you to identify and pair you with a mentor.

#### • CEO Roundtables (If available)

GrowFL CEO Roundtables provide the opportunity every CEO needs to discuss business practices and management strategies in a confidential setting with peers. Ten times a year each roundtable group, led by a trained facilitator, discusses how to overcome obstacles in areas such as finance, employee relations, legal compliance, marketing and many others.
